RESOLUTION APPROVING ORDINANCE NO. 09, SERIES OF 2018 ENTITLED "ORDINANCE AUTHORIZING THE BORROWING OF THE PROVINCE OF BATAAN FROM THE LAND BANK OF THE PHILIPPINES FOR A TERM LOAN IN THE TOTAL AMOUNT OF FOUR HUNDRED FIVE MILLION PESOS (\$\frac{1}{2}\$405,000,000.00) TO FINANCE THE DESIGN, BUILD AND SUPPLY OF THE FIT OUT OF THE NEW GOVERNMENT CENTER OR THE BUNKER AND THE IMPROVEMENT OF PEOPLE'S CENTER WHICH WILL INCLUDE RENOVATION AND RETROFITTING OF THE BATAAN PEOPLE'S CENTER AND THE SUPPLY AND INSTALLATION OF ITS AIR CONDITIONING AND COOLING SYSTEM AND HEREBY AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE ALBERT S. WHEREAS, pursuant to Section 296 of the Local Government Code of 1991, any Local Government Units may create indebtedness, and avail of credit facilities to finance local infrastructure and other socio-economic development projects in accordance with the approved local development plan and public investment program;

WHEREAS, the construction of the new Bataan Government Center or the Bunker will soon be completed for turn over to the Provincial Government;

WHEREAS, the JV Agreement between the Province and the AlloyMTD does not include the fit out, furnitures and fixtures of the Bunker;

WHEREAS, the fit out of the Bunker is necessary for its immediate use and for the transfer of various government agencies and offices to the said building;

WHEREAS, the Bataan People's Center also needs air conditioning and cooling system for its comfortable use by the people;

WHEREAS, the Land Bank of the Philippines (LBP) approved to finance the Design, Build and Supply of the fit out of the Bunker and the Supply and Installation of air conditioning and cooling system of the Bataan People's Center through a term loan of FOUR HUNDRED FIVE MILLION PESOS (\$\P\$405,000,000.00);

WHEREAS, the Provincial Government of Bataan is willing to avail of the term loan of FOUR HUNDRED FIVE MILLION PESOS (\$\frac{P}\$405,000,000.00) from LB to finance the Design, Build and Supply of the fit out of the Bunker, the improvement of the People's Center which will include the renovation and retrofitting of the Bataan People's Center and the Supply and Installation of its air conditioning and cooling system;

NOW THEREFORE, on motion of Board Member Jose C. Villapando, Sr., duly seconded by Board Member Manuel N. Beltran and Board Member Edgardo P. Calimbas, be it;

BE IT ENACTED, as it is hereby ENACTED, by the Sangguniang Panlalawigan of Bataan in a session assembled that:

SECTION 1. The Provincial Governor, Hon. Albert S. Garcia, in representation of the Province of Bataan, is hereby authorized, to enter into the LOAN AGREEMENT with the LAND BANK OF THE PHILIPPINES (LBP) in accordance with Section 297 of Republic Act No. 7160 or the Local Government Code for a term loan in the total amount of FOUR HUNDRED FIVE MILLION PESOS (\$\frac{1}{2}\$405,000,000.00) under the terms and condition herein set forth and such other terms and conditions as may be agreed upon with LBP for the purpose of funding the following government projects:

SECTION 2. The Provincial Governor shall have full power and authority to represent the Province of Bataan in signing, executing and delivering such agreements, contracts, deeds, papers, and documents as may be necessary and proper for the full and total implementation of the authority herein granted;

SECTION 3. The said priority projects enumerated in Section 1 hereof are hereby certified to be local infrastructures and/or socio-economic development projects in accordance with the approved local development plan and public investment program of the Province of Bataan;

SECTION 4. Terms and conditions of the loan:

- A. Borrower: Provincial Government of Bataan;
- B. Lender: Land Bank of the Philippines;

✓. Term Loan Amount: FOUR HUNDRED FIVE MILLION PESOS (₱405,000,000.00);

D. Purpose: To finance the Design, Build and Supply of the fit out of the new Government Center or the Bunker (\$\partial 315,000,000.00) and the Improvement of the Bataan People's Center which will include the renovation and retrofitting of the Bataan People's Center (\$\partial 50,000,000.00) and the Supply and Installation its air conditioning and cooling system (\$\partial 40,000,000.00);

E. Interest Rate: Variable rate at the time of release (currently at 5.50% per annum, subject to quarterly repricing);

F. Term: Ten (10) years inclusive of one (1) year grace period on principal;

G. Fees and other charges:

- Handling fee of 1% based on the approved amount shall be waived;
- 2. Commitment fee of ½% based on the unavailed portion of the loan shall be waived;
- Application, appraisal and inspection fees shall be waived;
- Gross Receipt Tax (GRT) shall be for the account of LANDBANK;
- Prepayment fee shall be waived, however, a prepayment fee of 3% based on outstanding loan balance shall be imposed in case of loan take-out by other bank.
- H. Penalty charge: Twenty-four percent (24%) per annum, in case of non-payment, shall be charged to start on the day after the due date of loan amortization/credit accommodation up to the date of settlement;
- Collateral: Assignment of Internal Revenue Allotment;
- J. Other terms and conditions:
 - Opening of Debt Servicing Reserve Account with equivalent deposit for any amortization is not required;
 - Subject further to the terms and conditions/documentary requirements that may be imposed by LANDBANK's Approving Committees and Legal Services Department.
- K. Documentation: The facility will be governed by the loan documents containing covenant conditions precedent and default provisions acceptable to all parties to the transaction.

SECTION 5. The Province hereby appropriates the proceeds of the above borrowing exclusively to finance the projects as stated in Section 1 hereof and other financial obligations relative thereto. Provided, However, that the Provincial Governor with the concurrence of the Land Bank of the Philippines, may cause the substitution of the project as the need may arise;

SECTION 6. The Province will appropriate and provide for any amount of expenses which will be incurred in the construction of the said project which will exceed the amount of proceeds of the loan agreement with the Land Bank of the Philippines;

SECTION 7. Any Ordinance or parts thereof, inconsistent with this enactment is hereby repealed or amended accordingly;
