PROVINCIAL ORDINANCE NO. 17 Series Of 2020

ORDINANCE IMPOSING NEW CURFEW HOURS FOR THE PROVINCE OF BATAAN

WHEREAS, President Rodrigo Roa Duterte issued Presidential Proclamation No. 922 series of 2020 declaring a State of Public Health Emergency throughout the Philippines given the COVID-19 pandemic, enjoining all government agencies and Local Government Units (LGU) to render full assistance and cooperation during the pendency of this health crisis;

WHEREAS, in order to overcome the present threat of COVID-19, the Province of Bataan must require simultaneous efforts on different fronts;

WHEREAS, the Province of Bataan is steadily under Modified General Community Quarantine (MGCQ), which is the most lenient quarantine measure;

WHEREAS, while there is a need to still adopt concrete measures to prevent, contain and restrict the spread of the COVID-19 virus, there is also a need to balance this with other aspects and interest, especially the need for the people to work and earn a living;

WHEREAS, the Office of the President, through the Presidential Spokesperson, mentioned in a statement that curfew hours can be adjusted to give way to the Filipino Christmas tradition of Simbang Gabi;

NOW THEREFORE, BE IT ENACTED, in regular session assembled that:

Section 1. New Curfew Hours - A curfew from 10:00 in the evening to 3:30 in the morning is hereby imposed in the Province of Bataan, during which period of time everyone is prohibited from being outside of their respective residences, subject to the exceptions contained herein below.

Section 2. Exceptions - Those coming from or going to work are exempted from the curfew hours provided they can show proof of such employment and relevant schedule.

Section 3. Penalties - The following penalties shall be meted-out against those violating the provisions hereof:

Offenses	Penalty
1 st	2 hours of community service
2 nd	4 hours of community service
3 rd and subsequent	6 hours of community service

Section 4. Repealing Clause - All ordinances contrary to or inconsistent with this Ordinance are hereby repealed or modified accordingly;

Section 5. Separability Clause - If any part or provision of this Ordinance is declared unconstitutional or invalid, the same shall not affect the validity and effectivity of the other parts or provisions thereof.

Section 6. Effectivity Clause - This ordinance shall take effect immediately after compliance with the relevant requirements and taking into consideration the present constraints posed by the COVID-19 pandemic, and shall continue to be effective unless lifted by the Sangguniang Panlalawigan.
