APPROVING THE CREATION OF VARIOUS DIVISIONS AND POSITIONS UNDER THE OFFICE OF THE PROVINCIAL GOVERNOR - PROVINCE OF BATAAN.

"WHEREAS, the Sangguniang Panlalawigan is in receipt of a request from the Provincial Governor, Hon. Albert S. Garcia, for the creation of various divisions, including the positions necessary thereof, in the Office of the Provincial Governor of the Province of Bataan;

WHEREAS, Art. 98 (1)(viii) of the IRR of RA 7160 or the Local Government Code of 1991 provides that the Sangguniang Panlalawigan as the legislative body of the province shall..... determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from provincial funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the Provincial Government;

WHEREAS, upon review and deliberation, the Sangguniang Panlalawigan finds the same in order without prejudice to relevant laws, rules and regulations;

2. Special Assistance Program Office (SAPO) Division

- To be responsible for the providing assistance and support to indigents and qualified patients/constituents.
- a. One (1) Community Affairs Officer II, SG-15
- b. One (1) Administrative Officer I, SG-11
- c. Four (4) Administrative Aide III, SG-3
- d. One (1) Administrative Aide II, SG- 2
- e. One (1) Administrative Aide IV, SG-4
- f. Three (3) Administrative Assistant I, SG-7

3. Youth Development Office (YDO) Division

- To be responsible for the promotion of youth programs and projects for the protection of youth's physical, moral, intellectual and social well-being through the active participation of the youth in government, public/civic affairs.
- a. One (1) Youth Development Officer III, SG-18
- b. Two (2) Youth Development Officer I, SG-10
- c. One (1) Administrative Aide III, SG-3

4. Cultural Heritage Preservation Division (CHPO)

- To be responsible for the preservation of culture and heritage through various programs of the Provincial Government.
- a. One (1) Project Development Officer IV, SG-22
- b. One (1) Development Management Officer III, SG-18
- c. One (1) Museum Researcher, SG-14

5. Procurement Section

- To act as additional support unit of the Bids and Awards Committee
- a. One (1) Administrative Officer V, SG-18
- b. One (1) Administrative Assistant II, SG-8

SECTION 2. FUNDING. The corresponding salaries and other benefits of the new positions shall be appropriated and incorporated in the Annual or Supplemental Budget of the Provincial Government of Bataan.

SECTION 3. SEPARABILITY CLAUSE. If any part of this Ordinance is declared not valid, unconstitutional or unlawful, such declaration shall not affect or impair the remaining provisions, sections or parts hereof, which shall remain and continue to be in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect after ten (10) days from the date copy hereof is posted in a bulletin board at the entrance of the Provincial Capitol Building and in at least two (2) other conspicuous places.
