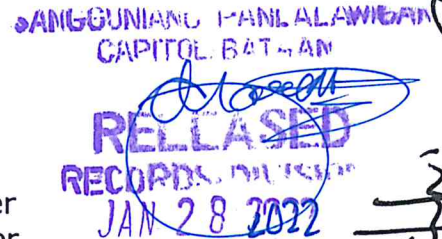

### AN ORDINANCE PENALIZING NON-COMPLIANCE WITH MANDATORY QUARANTINE REGULATIONS IN RELATION TO THE COVID-19 PANDEMIC.

**Section 1. Title** - This Ordinance shall be known as "Ordinance Penalizing Non-Compliance with Quarantine Regulations in Relation to the Covid-19 Pandemic."

**Section 2. Definition of Terms -**

- a. Quarantine - restriction on movement Imposed by the government intended to prevent the spread of a disease or virus.
- b. Quarantine Regulations - any policy, rule, or issuance, of national or local origin or scope, concerning the need to undergo quarantine for a prescribed number of days as a precautionary measure meant to address the spread of the COVID-19 virus.

**Section 3. Prohibited Acts -** The following acts or omissions shall be prohibited under this Ordinance:

- a. The failure of a person required by Quarantine Regulations to undergo quarantine;
- b. The failure of such a person to strictly and/or completely comply with all of the requirements set forth by Quarantine Regulations;
- c. The use of falsified quarantine certificate or any document evidencing purported compliance with Quarantine Regulations;
- d. Misrepresentation by any person for the purpose of exempting himself/herself from the coverage of Quarantine Regulations or for the purpose of falsely establishing his/her compliance therewith;
- e. Aiding or abetting a person with the end in view of violating or circumventing the provisions of Quarantine Regulations or this Ordinance;
- f. Any other act or omission resulting to a violation of Quarantine Regulations.

**Section 4. Penalties -** The following penalties shall be imposed for any violation of the provisions of this Ordinance:

First Offense	7 day imprisonment and/or ₱2,000.00 fine, at the discretion of the Court.
Second Offense	15 day imprisonment and/or ₱3,000.00 fine, at the discretion of the Court.
Third and Succeeding Offenses	30 day imprisonment and/or ₱5,000.00 fine, at the discretion of the Court.

The above penalties shall be without prejudice to the government's option to file other actions, in addition or in the alternative, in accordance with other existing laws, rules and regulations.

**Section 5. Repealing Clause** – All ordinance contrary to or inconsistent with this Ordinance are hereby repealed or modified accordingly;

**Section 6. Separability Clause** - If any part or provision of this Ordinance is declared unconditional or invalid, the same shall not affect the validity and effectivity of the other parts or provisions thereof.

**Section 7. Effectivity Clause** - This Ordinance shall take effect immediately upon compliance with the requirements of the relevant provision of Republic Act No. 7160.
