PROVINCIAL ORDINANCE NO. 06 Series of 2022

AN ORDINANCE CREATING POSITIONS UNDER THE OFFICE OF THE PROVINCIAL GOVERNOR, APPROPRIATING FUNDS THEREOF, AND FOR OTHER PURPOSES.

WHEREAS, Section 76 of the Local Government Code (LGC) of 1991 provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (1) (viii) of the same Code provides that the Sangguniang Panlalawigan shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of official and employees paid wholly or mainly from provincial funds;

WHEREAS, the Office of the Provincial Governor (PGO) is mandated to exercise powers and performs duties and functions necessary to promote the general welfare of the province;

WHEREAS, the Provincial Human Resource Management Office has endorsed a request for the creation of one (1) position in the PGO and two (2) positions under its Procurement Management Section;

WHEREAS, the Local Finance Committee, upon its review, certified that the proposed creation of said positions are compliant with the provisions of Section 325 of the LGC;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF BATAAN, IN REGULAR SESSION, ASSEMBLED:

SECTION 1. CREATION OF POSITION. The following plantilla positions are hereby created:

QUALIFICATIONS, SECTION 2. **DUTIES,** AND RESPONSIBILITIES. The qualifications, duties, and responsibilities of the newly created positions shall be in consonance with pertinent law, rules, regulations, and existing guidelines prescribed by the Civil Service Commission.

**SECTION 3. FUNDING.** The corresponding salaries and other benefits of the created positions shall be appropriated and incorporated in the Annual or Supplemental Budget of the Provincial Government of Bataan.

SECTION 4. **SEPARABILITY CLAUSE.** If for any reason, any section or provision of this Ordinance is declared to be unconstitutional or invalid, the remaining provisions thereof shall not be affected and shall remain in full force and effect.
