ORDINANCE FOR THE SCRAP AND POSITIONS UNDER THE OFFICE OF THE PROVINCIAL ACCOUNTANT, APPROPRIATING FUNDS THEREOF, AND FOR OTHER PURPOSES.

WHEREAS, Section 76 of the Local Government Code (LGC) of 1991 provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (1) (viii) of the same Code provides that the Sangguniang Panlalawigan shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of official and employees paid wholly or mainly from provincial funds;

WHEREAS, the Office of the Provincial Accountant is mandated to perform both accounting and internal audit services of the local government unit, maintain book of accounts and prepare financial statements, journals and other duties or functions as maybe provided by law or ordinance;

WHEREAS, the Provincial Human Resource Management Office has endorsed a request for the scrap and build of positions in the Office of the Provincial Accountant;

WHEREAS, the Local Finance Committee, upon its review, certified that the proposed scrap and build of positions in the Office of the Provincial Accountant is compliant with the provisions of Section 325 of the LGC;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF BATAAN, IN REGULAR SESSION, DULY ASSEMBLED:

SECTION 1. ABOLITION OF POSITION. The following existing vacant plantilla position is hereby abolished:

SECTION 4. FUNDING. The corresponding salaries and other benefits of the created position shall be appropriated and incorporated in the Annual or Supplemental Budget of the Provincial Government of Bataan.

SECTION 5. SEPARABILITY CLAUSE. If for any reason, any section or provision of this Ordinance is declared to be unconstitutional or invalid, the remaining provisions thereof shall not be affected and shall remain in full force and effect.

SECTION 6. EFFECTIVITY CLAUSE. This Ordinance shall take effect immediately upon its approval.
