PROVINCIAL ORDINANCE NO. 18 **SERIES OF 2023** 

AN ORDINANCE CREATING PLANTILLA POSITIONS UNDER **ENTERPRISE COOPERATIVE** THE **PROVINCIAL** DEVELOPMENT OFFICE (PCEDO).

WHEREAS, Section 76 of the Local Government Code of 1991 provides that every local government unit shall design and implement its own organizational structure and staffing pattern, taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (1) (viii) of the same Code provides that the Sangguniang Panlalawigan shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of official and employees paid wholly or mainly from provincial funds;

WHEREAS, the PCEDO performs a crucial function in the development and growth of cooperatives and micro, small and medium enterprises (MSMEs) in the province, hence the necessity for the creation of additional plantilla positions;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF BATAAN, IN REGULAR SESSION, DULY ASSEMBLED:

**Section 1. CREATION OF POSITIONS. -** The following plantilla positions are hereby created:

One (1)	Administrative Officer IV	SG-15
One (1)	Development Management Officer II	SG-15

**Section 2. QUALIFICATIONS, DUTIES, AND RESPONSIBILITIES. -** The qualifications, duties, and responsibilities of the newly created positions shall be in consonance with pertinent law, rules, regulations, and existing guidelines prescribed by the Civil Service Commission.

**Section 3. FUNDING. -** The corresponding salaries and other benefits of the created positions shall be included in the Annual or Supplemental Budget of the Provincial Government of Bataan.

**Section 4. SEPARABILITY CLAUSE. -** If for any reason, any section or provision of this Ordinance is declared to be unconstitutional or invalid, the remaining provisions thereof shall not be affected and shall remain in full force and effect.

**Section 5. EFFECTIVITY CLAUSE.** - This Ordinance shall take effect immediately upon its approval.
