WHEREAS, Section 76 of RA 7160, otherwise known as the Local Government Code of 1991, empowers LGUs to design and implement their own organizational structure and staffing pattern that will effectively address their development plans, objectives and priorities;

WHEREAS, Section 468 (a) (1) (viii) of the same Code provides that the Sangguniang Panlalawigan is empowered to determine the positions and salaries, including allowances and other emoluments and benefits of the employees of the provincial government;

WHEREAS, the transfer of offices and plantilla positions from the Bataan Youth Development Office (BYDO) and Cultural Heritage Preservation Division (CHPD) under the Office of the Provincial Governor to the Provincial Social Welfare and Development Office (PSWDO) and Provincial Tourism Office (PTO), respectively, will be more efficient for more streamlined operations and functions of the involved offices;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF BATAAN, IN REGULAR SESSION, DULY ASSEMBLED:

SECTION 3. The salaries and benefits of the transferred employees shall be appropriated in their new office assignments to be incorporated in the Annual Budget or Supplemental Budget of the Provincial Government of Bataan.

SECTION 4. Separability. - If for any reason, any section or provision of this Ordinance is declared to be unconstitutional or invalid, the remaining provisions thereof shall not be affected and shall remain in full force and effect.

SECTION 5. Effectivity. - The Ordinance shall take effect immediately upon its approval.
