**WHEREAS**, the Sangguniang Panlalawigan received an urgent request from the Provincial Governor for the enactment of an ordinance approving the purchase of transport vehicles (Multicabs);

**WHEREAS**, the Provincial Government of Bataan (PGB) was awarded the coveted SGLG Award for 2023 from the Department of Interior and Local Government (DILG). As an awardee, the PGB has become eligible to utilize the SGLG Incentive Fund to finance local development projects;


