PROVINCIAL ORDINANCE NO. 08 Series of 2024

AN ORDINANCE APPROVING THE PURCHASE OF A MOTOR VEHICLE TO BE UTILIZED BY THE PROVINCIAL PROJECT MANAGEMENT AND IMPLEMENTING UNIT (PPMIU) OF THE PROVINCIAL GOVERNMENT OF BATAAN (PGB) IN RELATION TO THE IMPLEMENTATION OF THE DEPARTMENT OF AGRICULTURE (DA) - PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP) IN THE PROVINCE.

WHEREAS, the Sangguniang Panlalawigan received a request from the Provincial Governor for the enactment of an ordinance approving the purchase of a motor vehicle to be utilized by the PPMIU of the PGB in relation to the implementation of the DA-PRDP in Bataan;

WHEREAS, the PGB, through the funding of the DA-PRDP, has implemented various sub-projects within the province which involve the engagement of rural

communities, Local Government Units (LGUs) and National Government Agencies (NGAs) in their modern planning and design;

WHEREAS, there is an approved project proposal for the purchase of a motor vehicle for the Social and Environmental Safeguards (SES) component of the PPMIU to further strengthen the PPMIU. This is critical for the effective implementation of PRDP sub-projects in the province;

WHEREAS, Department of Interior and Local Government (DILG) Memorandum Circular No. 2021-004 or the Revised Guidelines on Motor Vehicle Acquisition by the LGUs, in effect requires an ordinance approving purchases of vehicles for use by the LGUs;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN OF THE PROVINCE OF BATAAN, IN SESSION ASSEMBLED, THAT:

Section 1. Approval of Purchase. - The purchase of a motor vehicle (pick-up) is hereby approved. The technical specifications of the project are detailed below:

Section 2. Authority. - The Provincial Governor is hereby authorized to enter into and sign all documents necessary to purchase the vehicle.

Section 3. Separability. - If, for any reason, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 4. Effectivity. - This Ordinance shall take effect immediately upon its approval and compliance with the posting requirement under the Local Government Code of 1991.


