AN ORDINANCE APPROVING THE PURCHASE OF FOUR (4) UNITS OF ELECTRIC-POWERED VEHICLES TO BE UTILIZED FOR RESPONSE EFFORTS OF THE PROVINCIAL GOVERNMENT OF BATAAN (PGB) IN TIMES OF DISASTERS AND CALAMITIES.

WHEREAS, the Sangguniang Panlalawigan received an urgent request from the Provincial Governor for the enactment of an ordinance approving the purchase of four (4) units of electric-powered vehicles to be utilized for the efforts of the PGB in times of disasters and calamities;

WHEREAS, the purchase of vehicles is intended to improve PGB's capacity to provide immediate and effective responses to affected populations during disasters and calamities. This capability is critical in saving lives and property and developing disaster resilience in the Province of Bataan;

WHEREAS, the Bureau of Treasury - Region III have credited TEN MILLION PESOS (PHP 10,000,000.00) to the PGB to cover the funding requirements for the implementation of the priority programs and projects;

WHEREAS, Department of Interior and Local Government (DILG) Memorandum Circular No. 2022-105 or the Revised Guidelines on Motor Vehicle Acquisition by the LGUs, in effect requires an ordinance approving purchases of vehicles for use by the LGUs;

NOW, THEREFORE, be it ordained by the Sangguniang Panlalawigan of the Province of Bataan, in session assembled, that:

Section 1. Approval of Purchase. - The purchase of four (4) units of electric-powered vehicles are hereby approved. The technical specifications of the project are detailed below:

Section 2. Authority. - The Provincial Governor is hereby authorized to enter into and sign all documents necessary to purchase the vehicles.

Section 3. Separability. - If, for any reason, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 4. Effectivity. - This Ordinance shall take effect immediately upon its approval and compliance with the posting requirement under the Local Government Code of 1991.






