AN ORDINANCE APPROVING THE PURCHASE OF FOUR (4) UNITS OF ELECTRIC-POWERED VEHICLES TO BE UTILIZED TRANSPORTATION SERVICES OF THE PROVINCIAL **GOVERNMENT OF BATAAN (PGB).**

WHEREAS, the Sangguniang Panlalawigan received an urgent request from the Provincial Governor for the enactment of an ordinance approving the purchase of four (4) units of electric-powered vehicles to be utilized for transportation services of the PGB;

WHEREAS, the purchase of the vehicles is intended to acquire necessary assets that may be used to deliver public service while also promoting the use of renewable sources of energy and minimizing the carbon footprint;

WHEREAS, Department of Interior and Local Government (DILG) Memorandum Circular (MC) No. 2022-105, encourages Local Government Units (LGUs) to dedicate a percentage of their vehicle requirements to the purchase of motor vehicles using alternative fuel types such as bio fuels, flexi-fuel, natural gas, and solar and electric powered;

WHEREAS, pursuant to the said MC, the acquisition by the LGUs of a motor vehicle requires an ordinance approving purchases of vehicles for use by the LGUs;

NOW, THEREFORE, be it ordained by the Sangguniang Panlalawigan of the Province of Bataan, in session assembled, that:

Section 1. Approval of Purchase. - The purchase of four (4) units of electric-powered vehicles are hereby approved. The technical specifications of the project are detailed below:

Section 2. Authority. - The Provincial Governor is hereby authorized to enter into and sign all documents necessary to purchase the vehicle.

Section 3. Separability. - If, for any reason, any part or provision of this ordinance shall be held to be unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

Section 4. Effectivity. - This Ordinance shall take effect immediately upon its approval and compliance with the posting requirement under the Local Government Code of 1991.
