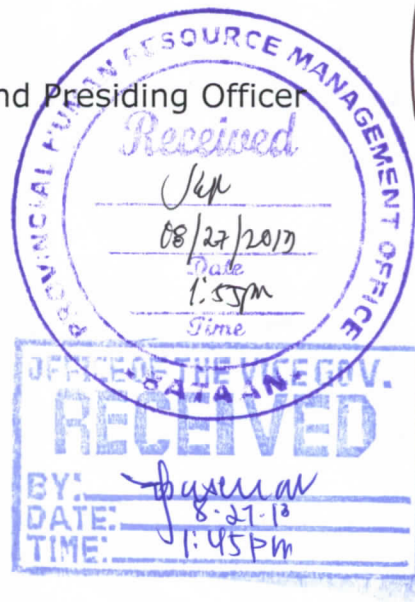

### RESOLUTION NO. 60

APPROVING ORDINANCE NO. 3, TITLED "AN ORDINANCE REINSTATING THE PREVIOUS PLANTILLA POSITIONS OF THE PROVINCIAL GOVERNMENT OF BATAAN AND AUTHORIZING THE PROVINCIAL GOVERNOR TO APPOINT PERSONNEL BASED ON THE PREVIOUS OLD PLANTILLA POSITIONS SUBJECT TO CIVIL SERVICE LAW, RULES AND REGULATIONS.

WHEREAS, by virtue of Resolution No. 108, series of 2004, passed and approved by the members of the Sangguniang Panlalawigan of Bataan, the Provincial Governor, Hon. Enrique T. Garcia, Jr. was authorized to undertake

the reorganization of the plantilla position of the Provincial Government of Bataan;

WHEREAS, corollary to the above, and thru the reorganization committee, the proposed new plantilla position was submitted before this Body and the same was approved in a duly convened session last February 19, 2008, through Resolution No. 33, Ordinance No. I;

WHEREAS, the deferment of the reorganization, which as reported still needs further review and reconsideration carries with it the non-implementation of the new plantilla positions;

WHEREAS, in order to fill up the needed vacant position necessary in the effective delivery of public service,

NOW THEREFORE, on motion of Board Member Jovy Z. Banzon, which was seconded by Board Member Reynaldo T. Ibe, Jr.;

BE IT ORDAINED, by the members of the Sangguniang Panlalawigan in a duly convened session to enact the following Ordinance:

#### ORDINANCE NO. 3

AN ORDINANCE REINSTATING THE PREVIOUS PLANTILLA POSITIONS OF THE PROVINCIAL GOVERNMENT OF BATAAN AND AUTHORIZING THE PROVINCIAL GOVERNOR TO APPOINT PERSONNEL BASED ON THE PREVIOUS OLD PLANTILLA POSITIONS SUBJECT TO CIVIL SERVICE LAW, RULES AND REGULATIONS.

Section I. This Ordinance hereby reinstates the previous plantilla position of the Provincial Government of Bataan; (hereto attached for reference)

Section II. This Ordinance further authorizes the Provincial Governor to appoint personnel which shall be based on the previous old plantilla positions subject to Civil Service law, rules and regulations;

Section III. To effectively implement the spirit and intent of this Ordinance, Resolution No. 33, embodying Ordinance No. I, titled "AN ORDINANCE APPROVING THE PROPOSED PLANTILLA POSITIONS OF THE PROVINCIAL GOVERNMENT OF BATAAN AS RECOMMENDED BY THE REORGANIZATION COMMITTEE AND FURTHER AUTHORIZING THE PROVINCIAL GOVERNOR TO IMPLEMENT THE SAME SUBJECT TO CIVIL SERVICE LAWS, RULES AND REGULATIONS", is hereby revoked;

Section IV. This Ordinance shall take effect upon approval.




