



WHEREAS, on October 22, 2018, the Provincial Government of Bataan passed its 2019 Annual Budget through Appropriation Ordinance No. 6, s. 2018 which contains various infrastructure projects, purchase of various equipment and vehicles to be sourced from borrowings or loans;

WHEREAS, there is a need to immediately implement all these infrastructure projects and procurements for the benefit of the Province and its constituents;

WHEREAS, to implement these projects and procurements, the Provincial Government applied for a loan with the Development Bank of the Philippines in the total amount of Six Hundred Ninety-Six Million Two Hundred Fifty Thousand Two Hundred Fifty-Nine Pesos and 02/100 Centavos (₱696,250,259.02) to fund the same;

WHEREAS, DBP offered to finance the implementation of the said various infrastructure projects and purchase of various equipment and vehicles for a term loan of Six Hundred Ninety-Six Million Two Hundred Fifty Thousand Two Hundred Fifty-Nine Pesos and 02/100 Centavos (₱696,250,259.02);

WHEREAS, the Provincial Government of Bataan is willing to avail of the term loan of Six Hundred Ninety-Six Million Two Hundred Fifty Thousand Two Hundred Fifty-Nine Pesos and 02/100 Centavos (₱696,250,259.02) from DBP to finance the said various infrastructure projects and purchase of various equipment and vehicles in the Province of Bataan;

NOW THEREFORE, on motion of Board Member Reynaldo T. Ibe, Jr., which was unanimously seconded, be it;

RESOLVED, as it is hereby resolved, to approve the following Ordinance:

ORDINANCE AUTHORIZING THE BORROWING OF THE PROVINCE OF BATAAN FROM THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) FOR A TERM LOAN IN THE TOTAL AMOUNT OF SIX HUNDRED NINETY-SIX MILLION TWO HUNDRED FIFTY THOUSAND TWO HUNDRED FIFTY-NINE PESOS AND 02/100 CENTAVOS (₱696,250,259.02) TO FINANCE VARIOUS INFRASTRUCTURE PROJECTS AND PURCHASE OF VARIOUS EQUIPMENT AND VEHICLES IN THE PROVINCE OF BATAAN, AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE ALBERT S. GARCIA, TO ENTER INTO LOAN AGREEMENTS WITH THE SAID BANK AND TO SIGN OTHER DOCUMENTS NEEDED FOR THIS PURPOSE AND APPROVING THE TERMS AND CONDITIONS THEREOF.

BE IT ENACTED, as it is hereby enacted, by the Sangguniang Panlalawigan of Bataan, in a session assembled that:

The Provincial Governor, Hon. Albert S. Garcia, in SECTION 1. representation of the Province of Bataan, is hereby authorized, to enter into LOAN AGREEMENTS with the DEVELOPMENT BANK OF THE PHILIPPINES (DBP) in accordance with Section 297 of Republic Act No. 7160 or the Local Government Code for a term loan in the total amount of SIX HUNDRED NINETY-SIX MILLION TWO HUNDRED FIFTY THOUSAND TWO HUNDRED FIFTY-NINE PESOS AND 02/100 CENTAVOS (₱696,250,259.02) under the terms and conditions herein set forth and such other terms and conditions as may be agreed upon with DBP for the purpose of funding various infrastructure projects and purchase of various equipment and vehicles as enumerated in the succeeding section, subject to the requirements under Section 123 of Republic Act No. 7653 and BSP Circular No. 402 as implemented by the Bangko Sentral ng Pilipinas. In this connection, the Provincial Governor shall have full power and authority to represent the Province of Bataan in signing, executing and delivering such agreements, contracts, deeds, papers, and documents as may be necessary and proper for the full and total implementation of the authority herein granted;

SECTION 2. The following priority projects subject of the loans are hereby certified to be local infrastructures and/or socio-economic development projects in accordance with the approved local development plan and public investment program of the Province of Bataan:

SECTION 3. Terms and conditions of the loan:

- A. Amount: Up to 100% of winning bid price or amount approved whichever is lower;
- B. Tenor: For infrastructure projects up to ten (10) years inclusive of one (1) year grace period on principal repayment, payable monthly.

For acquisition of vehicles and equipment – up to seven (7) years principal repayment, payable monthly.

- C. Interest Rate: Variable rate based on the prevailing market rate at the time of availment currently at 4.00% per annum. Interest is reviewable and payable monthly.
- D. Fees: Front-End, Extension and commitment fees are waived.
- E. Security: Deed of Assignment of Annual Regular income with holdout on deposit equivalent to one (1) quarter amortization.

Insurance cover of the assets to be financed to be placed with

F. Availability Period: Within one (1) year from the date of Notice of Approval;

SECTION 4. The foregoing terms and conditions of the loan as provided in the immediately preceding section are hereby approved.

SECTION 5. The Province hereby appropriates the entire proceeds of the borrowing exclusively to finance the above-mentioned projects and procurements and the financial obligations relative thereto, provided, however, that the Provincial Governor with the concurrence of the Development Bank of the Philippines may cause the substitution of projects as listed above as the need may arise.

SECTION 6. The Province will appropriate and provide for any amount of expenses which will be incurred in the construction of the said projects which exceeds the amount of the proceeds of the loan agreement with the Development Bank of the Philippines.

SECTION 7. Any ordinance or parts thereof, inconsistent with this enactment is hereby repealed or amended accordingly.

SECTION 8. This ordinance shall take effect upon its publication and compliance with all procedures required under Republic Act No. 7160 of an Ordinance for its validity, including the affixation of signatures of the Sangguniang Panlalawigan members, in concurrence thereto.
