ORDINANCE REPEALING ORDINANCE NO. 25, SERIES OF 2022, ENTITLED "AN ORDINANCE INSTITUTIONALIZING AND IMPLEMENTING THE UTILIZATION OF THE BATAAN VISITORS INFORMATION AND TRAVEL ASSISTANCE (VIS.I.TA.) APPLICATION FOR RELEVANT TOURISM ACTIVITIES IN THE PROVINCE OF BATAAN."

"EXCELLENT PUBLIC SERVICE TOWARDS A BETTER QUALITY OF LIFE FOR ALL"

WHEREAS, in connection with this, the Bataan Vis.I.Ta. App was launched to serve as an online registration platform for individuals and entities engaging in tourism activities in Bataan;

WHEREAS, after ten (10) months of running the system, and given the impending lapse of the term of subscription to the App, the Provincial Tourism Office (PTour) conducted consultations with the Provincial Information Technology Office (PITO), as well as with other information technology consultants, which led to the conclusion that the continued subscription to the said App is no longer cost-efficient;

WHEREAS, several measures have been issued relaxing health and safety protocols and requirements, resulting in immediate positive impacts;

WHEREAS, given the foregoing, PTour terminated the cloud subscription with Oracle Philippines for the Bataan Vis.I.Ta. App leading to halt in the use of the system;

WHEREAS, with this development, upon the request of PTour, there is a need to repeal Ordinance No. 25, series of 2022;

NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG PANLALAWIGAN IN REGULAR SESSION DULY ASSEMBLED:

Section 1. Repeal. – Ordinance No. 25, series of 2022, entitled “An Ordinance Institutionalizing And Implementing The Utilization Of The Bataan Visitors Information And Travel Assistance (Vis.I.Ta.) Application For Relevant Tourism Activities In The Province Of Bataan” is hereby expressly repealed.

Section 2. Effectivity Clause – This Ordinance shall take effect immediately upon compliance with the requirements of the relevant provisions of Republic Act No. 7160.


