REQUEST FOR EXPRESSION OF INTEREST FOR

Training of Emergency First Responder Course during the conduct of disaster preparedness training program for DepEd-Bataan Personnel Provincial Wide School Based Disaster Risk Reduction Education Seminar and Emergency Medical First Responder (EMFR) Training for Secondary Teachers (Teaching & Non-Teaching)

1. The Provincial Government of Bataan, through the 5% LDRRM Fund⁰⁰¹ intends to apply the sum of **P 1,190,000.00** being the Approved Budget for the Contract (ABC) to payments under the contract *Training of Emergency First Responder Course during the conduct of disaster preparedness training program for DepEd-Bataan Personnel Provincial Wide School Based Disaster Risk Reduction Education Seminar and Emergency Medical First Responder (EMFR) Training for Secondary Teachers (Teaching & Non-Teaching)*. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The Provincial Government of Bataan now calls for the submission of eligibility documents for *Training of Emergency First Responder Course during the conduct of disaster preparedness training program for DepEd-Bataan Personnel Provincial Wide School Based Disaster Risk Reduction Education Seminar and Emergency Medical First Responder (EMFR) Training for Secondary Teachers (Teaching & Non-Teaching)*. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before *June 22, 2023 at Provincial BAC Office, 4th Floor at the Bunker Capitol Compound, Balanga City, Bataan*. Applications for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion.
3. Interested bidders may obtain further information from *Provincial Government of Bataan* and inspect the Bidding Documents at the address given below 8:00 AM to 5:00 PM.
4. A complete set of Bidding Documents may be acquired by interested Bidders on *June 22 – July 11, 2023* from the address below in the amount of *FIVE THOUSAND PESOS (P 5,000.00) pursuant to the latest Guidelines issued by the GPPB*.
5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”, and its Implementing Rules and Regulations (IRR). The short list shall consist of *three (3) prospective bidders* who will be entitled to submit bids. The criteria and rating system for short listing are:
 - a) *Applicable experience of consultancy firm in Quality Management System-30 points*
 - *Number of completed similar projects in the last five (5) years*
 - *Number of years in the industry*
 - b) *Qualification of principal & key personnel of the consultant who may be assigned to the job- 50 points*
 - *Key personnel must have at least five (5) years working experience*
 - c) *Current workload relative to capacity – 20 points*

6. Bidding will be conducted among the short listed bidders through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the IRR of RA 9184.
 7. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.
 8. The Procuring Entity shall evaluate bids using the **Quality Cost Based Evaluation (QCBE)** procedure. The Procuring Entity shall indicate the weights to be allocated for the Technical and Financial Proposals. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
 9. The contract shall be completed within *15 Calendar Days*
 10. *Other necessary information deemed relevant by the Provincial Government of Bataan*
