PERMIT TO EXTRACT, TAKE, REMOVE, UTILIZE AND DISPOSE QUARRY MATERIALS FOR COMMERCIAL PURPOSES

After full compliance with the requirements for Small-Scale Mining Permit Application filed by San Luis Aggregates Trading at the Provincial Government Environment and Natural Resources Office (PG-ENRO), and the approval of Resolution No. 4, series of 2024 by the members of Provincial Mining Regulatory Board (PMRB) of Bataan. This Quarry Permit (QP), denominated as QP-B-24-002, is hereby granted to extract, take, remove, utilize and commercially dispose filling materials and other quarry resources not exceeding FIFTY THOUSAND METRIC TONS (50,000 MT) annually as authorized under the RA 7160 "Local Government Code" and RA 7942 "the Philippine Mining Act of 1995" and other relevant laws, decrees, ordinances, and implementing rules and regulations from the permit area situated in Barangay Paysawan, Bagac, Province of Bataan. The project area covers a total land area of 5 HECTARES and more particularly described as follows:

The terms and conditions of this Quarry Permit are as follows:

- This Quarry Permit is valid for a period of five (5) years or from September 11, 1. 2024 to September 11, 2029 renewable for the same period but not exceeding twenty five (25) years upon filing of application for renewal at least thirty (30) days before the expiry date; provided that the Permittee shall not have been guilty of any violation of the terms and conditions cited herewith, and that the Permittee has complied with the provisions of pertinent laws, ordinances, rules and regulations;
- This Permit shall be for the exclusive use and benefit of the Permittee and shall not 2. be transferred or assigned without the prior written recommendation of the Provincial Mining Regulatory Board (PMRB) of Bataan, and approval by the
