PERMIT TO EXTRACT, TAKE, REMOVE, UTILIZE AND DISPOSE QUARRY MATERIALS FOR COMMERCIAL PURPOSES

After full compliance with the requirements for Small-Scale Mining Permit Application filed by Miguel P. Estrella at the Provincial Government Environment and Natural Resources Office (PG-ENRO), and the approval of **Resolution No. 7, series of 2024** by the members of Provincial Mining Regulatory Board (PMRB) of Bataan. This Quarry Permit (QP), denominated as **QP-B-24-005**, is hereby granted to extract, take, remove, utilize and commercially dispose filling materials and other quarry resources not exceeding **FIFTY THOUSAND METRIC TONS (50,000 MT) annually** as authorized under the RA 7160 "Local Government Code" and RA 7942 "the Philippine Mining Act of 1995" and other relevant laws, decrees, ordinances, and implementing rules and regulations from the permit area situated in Barangay Sisiman, Mariveles, Province of Bataan. The project area covers a total land area of **4.9872 HECTARES** and more particularly described as follows:
