## PROVINCIAL ORDINANCE NO. 06

### AN ORDINANCE APPROVING THE PURCHASE OF TRANSPORT VEHICLES (MULTICABS).

#### SPONSORED BY:

**WHEREAS**, the Sangguniang Panlalawigan received an urgent request from the Acting Provincial Governor, Hon. Ma. Cristina M. Garcia for the enactment of an ordinance approving the purchase of transport vehicles (multicabs);

**WHEREAS**, the Provincial Government of Bataan (PGB) was awarded the coveted Seal of Good Local Governance (SGLG) for the year 2024 from the Department of the Interior and Local Government (DILG). As an awardee, the PGB has become eligible to utilize the SGLG Incentive Fund (SGLGIF) to finance local development projects;

**WHEREAS,** the PGB identifies the "Procurement of Transport Vehicles (Multicabs)" as the proposed project to be financed through the SGLG Incentive Fund. The multicabs will be distributed to selected barangays of the province to improve their delivery of services and to address their transportation needs during emergencies and disasters;

**WHEREAS,** Department of Interior and Local Government (DILG) Memorandum Circular (MC) No. 2022-105, or the Revised Guidelines on Motor Vehicle Purchase/Acquisition by the Local Government Units (LGUs) in effect require an Ordinance approving purchases of vehicles for use by the LGUs;

**WHEREAS,** DILG MC No. 2025-014 states that the eligible LGUs shall submit all documentary requirements to the DILG Regional Office thru the DILG Provincial Office within 90 calendar days upon receipt of the SGLGIF check/LDDAP-ADA for the processing of Notice to Implement (NTI);

**NOW THEREFORE,** be it ordained as it is hereby ordained by the Sangguniang Panlalawigan of the Province of Bataan, in session assembled, that:

**SECTION 1. APPROVAL OF PURCHASE.** - The purchase of transport vehicles (Multicabs) is hereby approved. The technical specifications of the transport vehicles are detailed below:

**SECTION 2. AUTHORITY.** - The Provincial Governor is hereby authorized to enter into and sign all documents necessary to purchase the vehicles.

**SECTION 3. SEPARABILITY.** - If, for any reason, any part or provision of this Ordinance is declared invalid or unconstitutional, the remaining parts or provisions not affected shall remain in full force and effect.

**SECTION 4. EFFECTIVITY.** - This Ordinance shall take effect after compliance with the relevant provisions of the Local Government Code.

UNANIMOUSLY ENACTED this 10<sup>th</sup> day of March 2025.
