ORDINANCE **AUTHORIZING** THE **PURCHASE** OF MULTI-PURPOSE VEHICLES (ELECTRIC VEHICLES).

SPONSORED BY:

WHEREAS, the Sangguniang Panlalawigan received an urgent request from the Provincial Governor Jose Enrique S. Garcia III for the enactment of an ordinance to authorize the purchase of multi-purpose vehicles (electric vehicles) to be utilized for patrol operations;

WHEREAS, the Provincial Government of Bataan (PGB) intends to purchase multi-purpose electric vehicles to enhance public service delivery, improve road safety, and promote environmental sustainability;

WHEREAS, this initiative benefits Bataeños by improving government response time, reducing air and noise pollution, and supporting a cleaner, healthier province reflecting PGB's commitment to cost-efficient and eco-friendly governance;

WHEREAS, the Bureau of the Treasury, Region III, has credited to the PGB's account the total amount of TWENTY-NINE MILLION EIGHT HUNDRED THOUSAND PESOS (PHP 29,800,000.00) to cover the funding requirements for the implementation of priority programs and projects of various LGUs, chargeable against the Local Government Support Fund - Financial Assistance to LGUs, FY 2024 General Appropriation Act, Republic Act No. 11975, Continuing Appropriations;

WHEREAS, Department of Interior and Local Government (DILG) Memorandum Circular (MC) No. 2022-105, or the Revised Guidelines on Motor Vehicle Purchase/Acquisition by the Local Government Units (LGUs) in effect require an Ordinance approving purchases of vehicles for use by the LGUs;

NOW, THEREFORE, be it ordained, as it is hereby ordained by the Sangguniang Panlalawigan, that:

SECTION 1. PURCHASE OF VEHICLES. - The purchase of multi-purpose vehicles is hereby authorized. The technical specifications of the multi-purpose vehicles (electric vehicles) are detailed below:

SECTION 2. AUTHORITY. - The Provincial Governor is hereby authorized to enter into and sign all documents necessary to purchase the vehicles.

SECTION 3. SEPARABILITY. - If, for any reason, any part or provision of this Ordinance is declared invalid or unconstitutional, the remaining parts or provisions not affected shall remain in full force and effect.

SECTION 4. EFFECTIVITY. - This Ordinance shall take effect immediately upon its approval and compliance with the posting requirement under the Local Government Code of 1991.
