WHEREAS, on April 10, 2025, Asiawide Land Specialist Development Corporation with an address at Cataning, Hermosa, Bataan filed an application for Private Gratuitous Permit under Application No. PGPA-B-025001, at the Provincial Government of Bataan thru the Environment and Natural Resources Office (PG-ENRO), to extract and dispose 5,220 cubic meters of excess materials from a proposed subdivision project area covered by TCT No. 038-2020007916, and TCT No. T-187918 located in Brgy. San Francisco De Asis I, Limay, Bataan pursuant to Section 73 (b) of the Department of Environment and Natural Resources (DENR) Administrative Order (DAO) No. 2010-21.

WHEREAS, Asiawide Land Specialist Development Corporation has complied with/submitted all the mandatory requirements for issuance of Private Gratuitous Permit;

WHEREAS, thru Resolution No. 5, series of 2025, the members of the Provincial Mining Regulatory Board (PMRB) of Bataan, Approved the application for Private Gratuitous Permit, denominated as PGP-B-025-001;

WHEREAS, this Private Gratuitous Permit is hereby granted to haul and transport the excess materials from the private land under Transfer Certificate of Title No. 038-2020007916, and Transfer Certificate of Title No. T-187918 as authorized under Republic Act 7160 "the Local Government Code of 1991" and Republic Act 7942 "the Philippine Mining Act of 1995" and other relevant laws, decrees, ordinances, and implementing rules and regulations;

WHEREAS, that the materials extracted from permit area shall be for personal use only;

WHEREFORE, this Private Gratuitous Permit shall be subject to the terms and conditions as follows:

- 1. This Permit is valid for a period of sixty (60) days or from June 23, 2025 to August 22, 2025, non-renewable and non-extendable;
- 2. This Permit shall be for the exclusive use and benefit of the Permittee and shall not be transferred or assigned without the prior written recommendation of the Provincial Mining Regulatory Board (PMRB) of Bataan, and approval by the Provincial Governor. The total land extent covered by this Permit shall be used for the purpose only of removing or extracting the materials herein authorized;
- 3. Statements made in the application for this Permit or those made later in support thereof shall be considered as conditions and essential parts of this Permit. Any misrepresentations therein shall be considered as a cause for the penalization of the Permittee and/or cancellation of this Permit;
