**PERMIT TO EXTRACT, TAKE, REMOVE, UTILIZE AND DISPOSE QUARRY MATERIALS FOR COMMERCIAL PURPOSES**

After full compliance with the requirements for Small-Scale Mining Permit Application filed by Romeo Y. Del Rosario at the Provincial Government Environment and Natural Resources Office (PG-ENRO), and the approval of **Resolution No. 4, series of 2025** by the members of Provincial Mining Regulatory Board (PMRB) of Bataan, this Quarry Permit (QP), denominated as **QP-B-25-003**, is hereby granted to extract, take, remove, utilize and commercially dispose filling materials and other quarry resources not exceeding **48,921 Metric Tons annually** as authorized under the Environmental Compliance Certificate (ECC-OL-R03-2025-0351) issued by the DENR-Environmental Management Bureau Region III, from the permit area situated in Barangay Puting Buhangin, Orion, Province of Bataan. The project area covers a total land area of **3.06 HECTARES** and more particularly described as follows:

The terms and conditions of this Quarry Permit are as follows:

1. This Quarry Permit is valid for a period of five (5) years or from July 01, 2025 to July 01, 2030 renewable for the same period but not exceeding twenty five (25) years upon filing of application for renewal at least thirty (30) days before the expiry date; provided that the Permittee shall not have been guilty of any violation of the terms and conditions cited herewith, and that the Permittee has complied with the provisions of pertinent laws, ordinances, rules and regulations;
2. This Permit shall be for the exclusive use and benefit of the Permittee and shall not be transferred or assigned without the prior written recommendation of the Provincial Mining Regulatory Board (PMRB) of Bataan, and approval by the Provincial Governor. The total land extent covered by this Permit shall be used for the purpose only of removing or extracting the materials herein authorized;
