NOW, THEREFORE, be it ordained, as it is hereby ordained by the Sangguniang Panlalawigan, that:

SECTION 1. Amendment of Section 1. Section 1 of Provincial Ordinance No. 08, series of 2025, is hereby amended to read as follows:

SECTION 1. PURCHASE OF VEHICLES. - The purchase of multi-purpose vehicles is hereby authorized. The technical specifications of the multi-purpose vehicles (electric vehicles) are detailed below:

SECTION 2. SEPARABILITY CLAUSE. - If, for any reason, any part or provision of this Ordinance is declared invalid or unconstitutional, the remaining parts or provisions not affected shall remain in full force and effect.

SECTION 3. REPEALING CLAUSE. - All prior ordinances or parts thereof inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY. - This Ordinance shall take effect immediately upon its approval and compliance with the posting requirement under the Local Government Code of 1991.




